Membership with The Nonprofit Partnership: An Overview

Before we dive in, here are some main details and notes regarding membership with The Nonprofit Partnership (NPP):

1. **Membership is open to nonprofit organizations.**

- a. Looking for business membership opportunities? [Learn more here.](#)
- 2. Our programming is held online, in-person, or hybrid. The in-person component of events and in-person programming will be generally held in **Erie, Pennsylvania** at our training facility at 609 Walnut St., Erie, PA 16502 (space permitting).
 - a. *We do not turn away members that are not local, but we want interested parties to consider if they will be able to get the most out of membership if they are located significantly farther from our location.*

3. **There are three tiers to membership:**

- a. Organizations with annual operating budgets under \$250,000 pay \$150 per year
- b. Organizations with annual operating budgets between \$250,000 and \$1,000,000 pay \$350 per year
- c. Organizations with annual operating budgets above \$1,000,000 pay \$670 per year
 - i. **Not sure where to find your organization's annual operating budget? Refer to line 18 – part 1 of your most recent 990.**
- 4. Membership renewal is yearly and is based off your organization's membership inception date. For example: those who join in May will then be due in May of the next year.
 - a. Reminders for renewal are sent by email and by postal mail.
- 5. Membership benefits apply to the organization as a whole: staff members, Board Members, and key volunteers.

Regular Programming

Members of The Nonprofit Partnership can attend regular sessions free of charge.

Erie Gives with The Erie Community Foundation

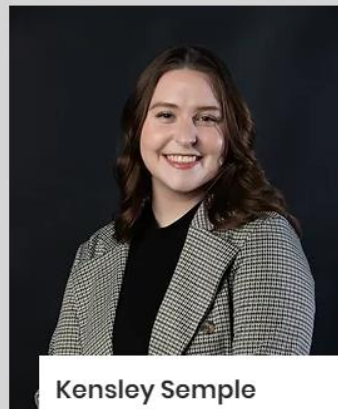
